DEVELOPMENT OF FACILITIES FOR PROCESSING AND DISPOSAL OF MSW ON B.O.T BASIS

City Municipal council Raichur is one of the famous city in Karnataka state spread over 60 Sq.kms, with a population of about 2,45,230 city is well known for Cotton production.

The present generation of MSW of CMC Raichur is 75 TPD is committed for safe disposal of MSW generated, as per MSW Rules 2000 and to comply with the mandatory recommendations of the committee constituted by Supreme Court of India.

City Municipal council Raichur intends to select developer for processing and disposal of MSW on BOT basis. The land for the purpose is located at EklaspurVillage, which is at 8 Km from the heart of the city.

City Municipal council Raichur invite “ EOI ” for the above mentioned work from reputed developers who have experience and capability in the field of processing of MSW in India.

I Scope of Work

- a. Designing the facilities for processing of MSW and land filling activities (Infrastructure development and establishment of tools and plants).
- b. Integrated processing facility for mixed waste input.
- c. The residue of inert should not be more than 20% for sanitary landfill.
- d. The developer will have to carry out O & M for a minimum period of 15 years which can be renewed on mutual consent.

- b. Details of technology, methodology, funding pattern, the developer propose for this project.
